With millions affected by modern slavery globally, including in Australia (<u>GLOBAL SLAVERY INDEX</u>), Lighthouse Engineering firmly opposes any form of exploitation. At Lighthouse Engineering, we firmly oppose any form of modern slavery and prioritize the well-being of our workforce.

#### Structure and Operations

Lighthouse Engineering employs a skilled workforce dedicated to delivering high-quality fabrication services. Our operations involve collaborating with various stakeholders, and we recognize the importance of upholding human rights throughout our business activities. We are committed to continuously improving our modern slavery policy by reviewing it periodically and fostering relationships based on integrity and ethical practices.

#### Supply Chain

We engage with a network of suppliers and subcontractors essential for our operations within Australia. In the financial year ending 2023, most of Lighthouse Engineering's procurement expenditure was within Australia. Australian suppliers are subject to compliance to Australian laws that prohibit slavery practices.

However, suppliers sourcing parts or components internationally may present a higher risk of modern slavery.

#### **Modern Slavery Risks**

Being the first Modern Slavery Statement for Lighthouse Engineering, we will continue to work to address the issue of modern slavery. We aim to thoroughly understand the risks associated with modern slavery within our industry.

Modern slavery encompasses various forms of exploitation, including human trafficking, forced labor, debt bondage, and child labor. We recognize the potential harm that our operations could inflict on individuals within our supply chain. Acknowledging these risks is crucial, and we are dedicated to identifying, assessing, and mitigating them as part of our commitment to human rights.
